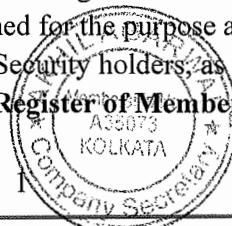

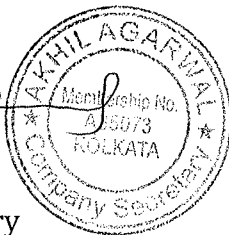
- a. The Annual Return states the facts as at the close of the aforesaid financial year correctly and adequately.
